6:24pm Internal Communications—Using board resources to work on Adoption, Affordability, Equity, Access, etc. should be a full board discussion and decision.

6:26pm Letters of Support for Sustainability Plan—Jane drafted talking points as well as a sample letter to use for reaching out to local representatives for support. It was sent to the primary delegates of each town for distribution. Jeff will follow up with those board members and Lisa will collect the letters. This needs to be done by July 26<sup>th</sup>.

**6:33pm Website**—Jane added a page for "underground service" information, how to prepare for installation, etc. This does not display correctly on some browsers. Matt will investigate.

**6:37pm Act 133**—Beginning this month, some rules regarding open meeting laws changed, with the intent to make the work of municipal boards and other public bodies more transparent. Meetings will be recorded and videos posted to the website for 30 days following approval of the minutes for each meeting. Task forces and subcommittees may now be considered public bodies and may be subjected to the same open meeting laws. More clarification is needed here.

**6:48pm Next Steps and Recap**—Carol recapped the next steps for Outreach and next topics to work on, including methods to reduce costs associated with Microsoft licenses. Lisa added that we are unable to "share" accounts, but can grant access to someone that is not a licensee.
